WHAT DOES CREDIT CONCEPTS DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and Income
- Account balances and payment history
- Credit history and credit scores

How?

All financial companies need to share **customers**' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons **Credit Concepts** chooses to share; and whether you can limit this sharing.

Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.		
	 Credit Concepts and its subsidiaries do not share with nonaffiliates so they can market to you. 		
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.		
	Credit Concepts Inc., and its subsidiaries do not jointly market.		

Other important information

For California Residents. We will not share information we collect about California residents with companies who are not affiliates, except as permitted by law, such as with your consent or to service your accounts. Among our affiliates, we will limit information sharing to the extent permitted by California law. You are not required to contact us for these elections to apply.
